ORDER:

The Director of Technical Education has reported that Sri Ramakrishna Mission Vidyalaya Polytechnic, Perianayakan-palayam, Coimbatore has come with a proposal to introduce a diploma course in Mechanical and Rural Engineering. Among all the Polytechnics and Institutions imparting Engineering. Education in Tamil Nadu, Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore has the most favourable background for introducing programmes with a rural development bias as the institution has an environment that is highly conducive to the success of such a programme. The Director of Technical Education has also stated that the All India Council for Technical Education has approved the introduction of diploma course in Mechanical and Rural Engineering with annual intake of 40 students, to be adjusted in the overall sanctioned intake of the Polytechnic. In the light of the abovereasons, the Director of Technical Education has permitted the Principal of the Institution to introduce the course from the academic year 1978-79, in anticipation of Government orders. He has also added in this connection that there was no commitment to Government for the years 1978-79 and 1979-80. But the total cost involved in the proposal is Rs.2,64,750/-. Of this, the State Government's commitment at 90% will be Rs.2,38,275/-, from 1980-81. The Director has also requested the Governfrom 1980-81. The Director has also requested the Government to grant autonomy to the Mechanical and Rural Engineering Diploma course. Subsequently, on the request of Thiru T.S. Avinashilingam Chettiar, the Director has recommended for grant of academic autonomy to the said Polytechnic. The Director has stated that with academic autonomy with more academic freedom, the instite can run the course in an effective way in providing the education and training for Rural Development activities and the proposal to grant autonomy to all diploma courses of the said Polytechnic does not involve any financial commitment.

2. The Government approve the proposal of the Director of Technical Education for the introduction of a diploma course in Mechanical and Rural Engineering in Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore, with an intake of 40 students within the overall intake of the Polytechnic, with effect from 1978-79.

3. The Government also approve the following non-recurring and 'recurring' expenditure in connection with the introduction of the new Diploma Course referred to in para 1 above in Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore.

- 4. Sanction is accorded to the payment of Rs.2,38,275/-(Rupees two lakhs thirty eight thousand and two hundred and seventy five only) to Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore being the State Government share equivalent to 90% of the expenditure (the total expenditure being Rs.2,64,750/-) on the introduction of the new course approved in para 2 above.
- 5. The Director of Technical Education is requested to ensure that the staff to be appointed to the new Diploma course approved in para 2 above should be well within the amount approved for the purpose i.e. Rs.66,000/-. The staff to be appointed for the said diploma course are eligible to draw Dearness Allowance, House Rent Allowance and City Compensatory Allowance in addition to their pay as per rules in force from time to time.
- 6. The expenditure is on 'New Service'. The expenditure should be initially met by an advance from the Contingency Fund, orders regarding which will be issued by Government in Finance (BG.I) Department. The Director of Technical Education is requested to apply, in the prescribed from, to the Government in Finance (BG) Department directly along with a copy of this order for sanction of advance from contingency Fund.
- 7. Sanction is accorded for the conferment of academic autonomy to the two diploma courses (i.e.) (i) Civil and Rural Engineering and (ii) Mechanical and Rural Engineering in the Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore with effect from 1980-81 subject to the condition that there should be no additional expenditure to Government.on this account.
- 8. The Government also ratify the action of the Director of Technical Education in having permitted the Principal, Sri Ramakrishna Mission Vidyalaya Polytechnic, Coimbatore to start the Diploma Course in Mechanical and Rural Engineering in anticipation of the Government orders from the academic year 1978-79.

9. The expenditure should be debited to "277.Education F.Technical Education-AC.Polytechnics-I.Non-Plan-AG.Grants-in-aid to Private Polytechnics-09. Grant in aid 1.Teaching (DPC No.277F ACAG 0911)
