LOCATION

The area is located within the Sri Ramakrishna Mission Vidyalaya, Periyanaickenpalayam campus on the Western and Eastern sides of Coimbatore – Mettupalayam road at Periyanaickenpalayam.

SLOPE

The area for the already constructed building within the Sri Ramakrishna Mission Vidyalaya, Periyanaickenpalayam campus is a plain land.

SOIL THICKNESS

On examination of the area it is revealed that the clay soil is noticed for a depth of 4 to 6 meters.

LAND USE PATTERN

The area is surrounded with buildings on all sides

DRAINAGE

There is no stream course passing within the campu.

RECOMMENDATION

The area applied by the Secretary, Sri Ramakrishna Mission Vidyalaya, Periyanaickenpalayam for regularization of already constructed buildings within the campus in S.F.Nos. 46, 47, 48, 49, 50/1, 54, 55/1, 55/2, 56, 57, 58, 59,60,61,62, 63, 64, 65/1, 65/2, 66,67,69/3,69/4, 69/5, 69/6, 70/1, 70/4, 71/1, 71/2, 72, 73, 74/3,78/1A, 78/1B, 90, 91, 92, 93/1, 93/2, 107/1, 107/2, 108, 109(part),110, 111, 112, 113,114 of Gudalur village, Coimbatore North Taluk is a plain land and Geo technically stable. Therefore it is recommended for the regularization of already constructed buildings within the campus of Sri Ramakrishna Mission Vidyalaya, Periyanaickenpalayam subject to the following conditions.

- 1. In future, construction activities should be carried out only after obtaining proper permission from the HACA.
- 2. There should not be any disturbance for the nearby streams and natural flow of water.
- 3. Proper drainage facility should be provided.
- 4. Eco system and green atmosphere should be developed by growing number of trees within the premises.
- 5. No hindrance shall be caused to adjoining lands.
- 6. Proper safety distance should be provided for the National Highway road
